INITIAL UNIVERSE

Energy Storage Technology Providers:

- Data Source: Clean Horizon's Energy Storage (CHESS) database is used to determine electro-chemical storage technology providers.
- Criteria:
 - Projects classified as "Electrochemical" with energy capacity ≥ 1 MWh are selected.
 - Companies listed as Energy Storage Technology Manufacturers are included.
 - Operational status in the energy storage business is confirmed.

Mining Companies:

- Data Source: Fastmarkets MB database is used to determine mining companies that product lithium.
- Criteria:
 - Companies classified as "BG" (battery grade) are selected.

SELECTION POOL

ESG Exclusions:

Companies listed in the ESG Exclusions Index by Solactive are excluded.

To be eligible a security must have:

- Free Float Market Cap (\geq USD 200 million or \geq USD 150 million for existing Index members).
- Three-month average daily trading volume (≥ USD 1 million).
- Publicly traded for at least 3 months.
- Not classified as 'Energy' by FactSet Economy Level.
