EURO STOXX 50® INDEX

SELECTION (WHAT GOES INTO THE INITIAL UNIVERSE)

The index universe are stocks in the Eurozone region defined by the EURO STOXX index.

SELECTION POOL (HOW IS WHAT IS IN THE UNIVERSE IN REFINED TO POTENTIALLY MAKE IT INTO THE INDEX):

- All stocks from the 20 EURO STOXX Supersector indices are ranked in terms of free-float market capitalization.
- The largest stocks are added to the selection list until the coverage is close to 60% of the free-float market capitalization of the corresponding EURO STOXX TMI Supersector Index.
- The largest 40 stocks are ordered in terms of market capitalization and the remaining 10 stocks are selected from the largest remaining current stocks ranked between 41 and 60.

WEIGHTING SCHEME

- Free Float Market Cap Weighted
- Components are capped at a maximum weight of 10%

REBALANCES/REVIEWS

Rebalanced quarterly and reviewed annually in September
