## **Material Description**

All bars were deemed to be London Good Delivery Palladium Bars.

#### **Audit Procedures**

- 1. Compared the records of the Custodian to the records provided by the Administrator to verify that the palladium bars are held in the name of the applicable account;
- 2. Reconciled the total weight of palladium bullion as recorded by the Administrator to the records of the Custodian as at the Audit Reference Date;
- 3. Visually checked each bar for the bar number, brand and purity;

- 4. Weighed a random sample of palladium bars, equating to approximately 5 percent of the bar list. The bars were weighed in troy ounces to the nearest thousandth of an ounce. Details of each bar weighed were recorded;
- 5. Reconciled the physical movement of palladium bars which occurred during the inspection period between the Audit Reference Date and the Audit Completion Date.

## Non-conformities:

There were no non-conformities identified in respect of the palladium bars held by the Custodian as of 31 May 2024 for the above numbered account.


