- Only securities listed on the Australian Securities Exchange.
- However, securities assigned to the following economies according to the FactSet Standard Classification are excluded:
 - Basic Materials, Energy and Finance.

SELECTION POOL

Security in the initial universe with the highest free float market capitalisation are added until the index has 100 stocks.

WEIGHTING SCHEME

Constituents capped at 10%.

REBALANCE/REVIEWS

Rebalanced quarterly and reviewed at least annually.
