### SELECTION (WHAT GOES INTO THE INITIAL UNIVERSE)

- Market Issue: Corporate debt only.

### SELECTION POOL (HOW IS WHAT IS IN THE UNIVERSE IN REFINED TO POTENTIALLY MAKE IT INTO THE INDEX)

- Bond Type: Fixed coupon bonds, step-up bonds medium term note, callable and puttable bonds and 144A securities are eligible for inclusion.
- Country of risk: Bonds with country of risk classified as developed markets by Solactive Index committee are eligible.
- Time to maturity: Must have at least 1 year to maturity on each Rebalancing Day. Bonds newly added to the Index must have a time to maturity of at least 20 months
- Time to maturity at issuance: Must have 15 years of less time to maturity at issuance
- Currency: US Dollar Denominated
- Issue Amount Outstanding: At least USD 400 million.
- Issuer total remaining principal amount outstanding of all bonds from the issuer: at least USD 1 bn.
- Credit rating: Must be rated by at least one of these 3 rating agencies: Standard & Poor's, Moody's, and Fitch.
  - Between BB+ and C

### SELECTION POOL EXCLUSIONS (WHAT IS EXCLUDED FROM THE INDEX)

- The following market types are excluded: Government debt, quasi-sovereign debt, debt guaranteed or backed by governments, REGS securities, municipal bonds, Brady bonds and restructured bonds, private placements.
- Collateral Type: Covered bonds/notes are excluded
- Full Call / Full Tender: All bonds for which a full call or full tender offer is announcements the effective date in the upcoming month will be excluded.

### WEIGHTING SCHEME

- Market Value Weighted
- Maximum weight capped at 3%

### REBALANCES/REVIEWS

- Rebalanced Monthly and Reviewed Annually.
